PART 1

1.1 Purpose:

The report is submitted to Cabinet pursuant to the Implementation Plan in relation to the Council Strategic Plan 2012/15 and Budget 2012/13 agreed by Cabinet on 28 March 2012. The purpose of this report is to inform Cabinet how the proposed budget saving relating to mobile telephones issued to officers has been achieved.

1.2 Recommendation(s):

It is recommended that Cabinet note that targeted saving of $\pounds14,400$ in relation to mobiles telephones issued to officers can be achieved, and that budgets will be adjusted accordingly in year.

1.3 Forward plan:

The Council Strategic Plan and 2012/13 Budget – Implementation Plan appears on the Forward Plan for the period 1 May to 31 August 2012.

1.4 Council plan and policy framework:

The report relates to a specific item in the Council's Budget 2012/13 and is relevant to Priority 1 in the Council Strategic Plan 2012/15, Sustaining our front line services within the Council, but only spending what we can afford.

1.5 Information:

- 1.5.1 On 1 March 2012 Council agreed as part of the budget proposals to reduce the number of officer mobile phones by 20% to deliver a saving of £14,400.
- 1.5.2 Following a procurement exercise, a new 2 year contract for mobile telephony and data services was signed in January 2012 with Everything Everywhere (Orange). One of the key aspects of the new contract is the removal of a fixed monthly charge for each mobile telephone. This removal of the fixed monthly charge element across individual mobile phone contracts delivers the required saving.
- 1.5.3 Analysis of the forecasted cost of officers' mobile phones against budget has been carried out and service budgets will be reduced to reflect where those savings will arise. Budget holders will be advised of the change to their budgets.
- 1.5.4 Work is on-going to reduce the overheads and call costs of mobile telephony to the organisation, recent changes include the introduction of a voluntary salary reduction scheme for personal usage for officers. The cost of mobile telephony continues to be monitored as part of the Council's usual budget management practices.

1.6 Decision options:

- 1.6.1 Cabinet can accept that the saving will be achieved and report this outcome to council.
- 1.6.2 Cabinet can reject this report.

1.7 Reasons for recommended option:

The saving will be achieved in year. Budgets will be reduced proportionally once consultation with budget holders has occurred.
