1.1 Executive Summary:

The purpose of this report is to seek Cabinet's approval to the proposed response to the recommendations of the Environment Sub-Committee in relation to its study of waste collections post 2017 in North Tyneside. The Environment Sub-Committee of the Overview, Scrutiny and Policy Development Committee report was presented and recommendations were made to Cabinet at its meeting on 12 September 2016.

In accordance with Section 21B of the Local Government Act 2000, Cabinet is required to provide a response to the recommendations of the Overview, Scrutiny and Policy Development Committee within two months. In providing this response, Cabinet is asked to state whether or not it accepts each of the recommendations and the reasons for this decision. Cabinet must also indicate what action, if any, it proposes to take.

1.2 Recommendation(s):

It is recommended that Cabinet agrees the proposed responses to the recommendations from the Overview, Scrutiny and Policy Development Committee in relation to its study into waste collections post 2017, as shown in Appendix 1 of this report.

1.3 Forward Plan:

Twenty eight days notice of this report has been given and it first appeared on the Forward Plan that was published on 10th October 2016.

1.5 Information:

1.5.1 Background

As part of the 2015/16 Environment Sub Committee work programme members agreed to carry out a study into the implications of the cessation of the Weekly Collection Support Scheme on the waste collection service. A Sub-group was set up to carry out the investigation. The main focus of the study was to consider the various options available in relation to the collection of household waste within the borough and to identify how changes to the collection of waste can improve levels of recycling in the borough. Members held a series of evidence gathering meetings between October 2015 and June 2016.

The findings and recommendations of the Environment Sub-committee in relation to its study into the Authority's waste collection service post 2017 were presented to Cabinet (12 September 2016).

1.6 Decision Options:

The following decision options are available for consideration by Cabinet:

Option 1

Cabinet may accept the recommendation set out in paragraph 1.2 above.

Option 2

Cabinet may not accept the recommendation set out in paragraph 1.2 above.

Option 1 is the recommended option.

1.7 Reasons for Recommended option:

It is recommended that Cabinet agree option 1 in order to support the continued efforts to reduce waste and increase recycling in the Borough.

It is anticipated that all actions can be completed using existing resources if agreement is received to carry over an element of the Weekly Collection Support Scheme grant to deliver education and awareness into 2017/18. Evidence from other authorities and external expert groups was considered by the sub-group and information from previous engagement exercises and consultations with residents and the Residents Panel was also considered.

The use of more communal and innovative solutions for refuse storage and collection in new developments should provide environmental benefits both in waste reduction and in fewer vehicle movements.

Any reduction in packaging by manufacturers and supermarkets would be welcome and would contribute to the reduction of waste arising which is the top action of the waste hierarchy.
