## **Introduction**

1. This addendum report relates to the 2013/15 Financial Planning and Budget Process Report to Cabinet 28 January 2013 Annex 1 Section 2.
2. This addendum identifies the key messages from engagement between the preparation of the report published on 18 January 2013 and 22 January 2013.
3. It also provides additional information on additional budget engagement events in Appendix A.

## **Key messages from budget engagement**

4. The budget engagement events between 18 January and 22 January 2013 all relate to the proposals for Adult Social Care. A further seven sessions have taken place. These have included:
  - meetings with Trade Unions to discuss the direct impact of changes for Authority staff,
  - three Adult Social Care staff sessions with around 240 people,
  - a service user event for people with learning disabilities,
  - a voluntary sector forum for organisations representing carers
  - a meeting with Extra Care Housing scheme residents.
5. Key feedback from these events is set out below:
  - People have asked for more information and time to understand the implications of introducing a well being charge within the extra care schemes. The Authority has agreed to hold extra sessions for all residents within the schemes and to work with each of the Housing Associations going forward.
  - Providers from the community and independent sectors have welcomed the proposed changes to reablement services and are keen to continue to work in partnership with the Authority, on this agenda. Similarly Adult Social Care staff have welcomed the proposal to integrate all reablement services.
  - Consultation is ongoing with staff within Adult Social Care.
