#### C36/07/13 Chair's Remarks

The Chair made the following remarks:

The Chair welcomed Councillor Wendy Lott following her election to the Council at the By-Election held in Riverside Ward on 4 July 2013.

#### C37/07/13 Declarations of Interest

The following declarations of interest were made:

#### Item 3 – Kings Priory Academy Proposals

Councillor John Hunter – non-registerable personal interest – grandchild attends Priory Primary School, Tynemouth.

The Cabinet Member for Children, Young People and Learning responded to queries raised at the meeting about whether he should declare an interest in this matter due to his association with the NUT by stating that he was an Executive Member of the NUT; he was not employed by the NUT and this did not impact upon his role in decision making on this matter. He also referred to some misinformation set out in The Spectator magazine referring to his role within the NUT.

## C38/07/13 Kings Priory Academy Proposal

[N.B. Councillor John Hunter withdrew from the meeting for the duration of the discussion and voting on this item.]

The Council received a report which provided an update upon the Kings Priory Academy proposals to enable Members to express their views upon the decision of the Secretary of State for Education to approve those proposals.

The decision of the Secretary of State had been notified to the Authority during evening of 5 July 2013. Due to the time sensitive nature of the issues and to avoid any unnecessary delays, an extraordinary meeting of Council was necessary to provide an opportunity for the Cabinet to consult with all Members prior to determining the Authority's next steps.

The report outlined a chronology of the events leading up to the Secretary of State's decision. It included information regarding an assessment of the impact of entering into the arrangements upon maintained schools and academies in the area; correspondence between the Authority and the Woodard Trust, the Governing Body of Priory Primary School and the Department for Education; and the decision making process of Priory Primary School Governing Body.

The report also set out grounds to take steps to secure that the Secretary of State reconsidered the decision to enter into the funding agreement to create the Kings Priory Academy.

At this point, the Chair announced that due to the late receipt of the papers, the meeting was adjourned for 15 minutes in order to give Members of the Council further time to read the papers.

It was moved by Councillor I Grayson and seconded by Councillor G Bell that:

### "Council agrees to:

support Cabinet in taking all appropriate steps to secure that the Department for Education reconsiders the decision to enter into the funding agreement to create the Kings Priory Academy to ensure that errors are rectified and the impact upon other schools is properly considered."

An amendment was moved by Councillor J Allan and seconded by Councillor M Green to add the following words at the beginning of the Motion:

'Cabinet is asked to note that Council is opposed to the Kings Priory Academy proposals because of the impact on education across the whole of the Borough'.

The amendment, on being put to the meeting, was approved by 37 votes to 7 votes.
