C84/02/15 2015-2016 Financial Planning and Budget Process: 2015/16 Budget and Council Tax Requirement Submission to the Authority

The Chair announced that the purpose of the meeting tonight was to enable the Elected Mayor and Cabinet to submit to Council their proposals for the estimates of amounts for the calculation of the Council Tax requirement for 2015/16. The General Fund Revenue

Budget proposals on which these calculations would be based were submitted to Council in support of these estimates.

The submission of the Elected Mayor and Cabinet's estimates of amounts for the 2015/16 General Fund Revenue Budget started the Council's process in setting the Council Tax levels.

The Elected Mayor and Cabinet's proposals were submitted to this meeting but would be moved and seconded at the reconvened Council meeting on 19 February 2015. There was an opportunity for Members to ask questions about the Cabinet's proposals at this meeting.

Between the submission of the proposals to this meeting and the consideration that would take place at the Council meeting on 19 February 2015, Members were able to submit objections to the Cabinet's proposals. Any objections received would be considered at the reconvened meeting on 19 February 2015.

Members were now in receipt of the report containing the Cabinet's proposals in relation to the Council Tax Requirement and 2015/16 General Fund Revenue Budget.

The Cabinet Member for Finance and Resources introduced the Elected Mayor and Cabinet's budget proposals.
