# PART 1

# 1.1 Executive Summary:

Full Council is required to formally consider the request to change the location of Polling District RB Polling Station (formerly Age UK Centre, Park Road, Whitley Bay) for the North Tyneside Mayoral Election which is to be held on 4 May 2017, and future elections.

## 1.2 Recommendation(s):

It is recommended that Council consider and agree the alternative location for polling place at Livingstone Hall, Whitley Bay Baptist Church, Park Parade as set out in Appendix 1.

#### 1.3 Forward Plan:

Twenty eight days notice of this report has been given and it first appeared on the Forward Plan that was published on 3 October 2016.

## 1.4 Council Plan and Policy Framework

#### 1.5 Information:

## 1.5.1 Background

Under current electoral legislation the Authority is required to designate a polling place for each polling district within its area and also to keep such polling places under review.

To encourage and facilitate voter participation, all electors should have reasonable facilities in which to vote. The Electoral Commission recommends that the following

factors are taken into consideration when reviewing existing polling places or when assessing new polling places:

- The location: is it reasonably accessible within the polling district? Does it avoid barriers for the voter such as steep hills and major roads? Are there any convenient transport links?
- Size: Can it accommodate more than one polling station if required? If multiple polling stations are required, is the polling place ample enough to accommodate all voters going into and out of the polling stations, even where there is a high turnout?
- Suitability: is the building readily available in the event of any unscheduled elections?
  Is there any possibility that the building may be demolished as part of a new development?
- Accessibility: Is the building accessible to all those entitled to attend the polling place?

## 1.5.2 Current Issues

Age UK has informed the Returning Officer that the building at Park Road, Whitley Bay will no longer be available to use as a polling place. It has therefore been necessary to look for an alternative facility. Other places within the polling district have been investigated but only one was available for electoral use.

# 1.5.3 The Alternative Proposed Provision

As an alternative to the above Livingstone Hall, Whitley Bay Baptist Church, Park Parade has been identified as suitable. The Hall is accessible to all voters, and is located near to the existing polling place. There is nearby parking, however this is a residential area.

The proposal supports the Authority's equality and diversity policies and the advice of the Electoral Commission by seeking to provide all electors with reasonable and practicable facilities to vote. An Equality Impact Assessment, attached at Appendix 2, has been undertaken in relation to the proposed change to the polling place in Whitley Bay Ward.

Any further changes to the current polling place and district proposals will be subject to further equality impact assessments as they arise.

## 1.6 Decision options:

The following decision options are available for consideration by Council.

# Option 1

To agree to the recommendations, as set out in Appendix 1.

## Option 2

To request that officers undertake further work to identify an alternative proposal to the one submitted to Council and report back to the next Council meeting.

Option 1 is recommended for the following reasons:

Livingstone Hall, Whitley Bay Baptist Church, Park Parade is accessible to all voters, and is located near to the existing polling place. There is nearby parking, however this is a residential area.
