### Cabinet Response to Overview and Scrutiny Recommendations Completed Action Plan

#### Public Rights of Way

In accordance with Section 122 of the Local Government and Public Involvement in Health Act 2007, Cabinet is required to provide a response to the recommendations of the Overview, Scrutiny and Policy Development Committee within 2 months. The website should also include a facility for claiming new or modifying existing rights of way and for users to report issues on the rights of way network.
