# JSLC16/01/17 Project Apollo and Financial Disputes Update

The Committee received a progress report on the sale of the Street Lighting PFI Special Purpose Vehicle (SPV), Project Apollo, and the proposed settlement of a number of financial disputes between Newcastle City Council, North Tyneside Council and SSE.

At its meeting in December 2015, the Committee considered the initial proposal from the supplier SSE regarding Project Apollo, when it was agreed that officers would continue to investigate and negotiate with SSE prior to contract sign-off to secure a position which left both Authorities at no disadvantage. Following several meetings, officers were now analysing and considering the financial information regarding the preferred bidder in order to demonstrate that the transactions represented best value for money in the current market conditions. The Authorities had also negotiated a number of financial disputes with SSE over the past 18-24 months, each based on individual merits with a view to a wider settlement agreement.

Throughout the negotiations SSE maintained their position that they had continued to be aware of the Service Provider's obligations with regard to best value as set out in the Project Agreement, however they did acknowledge that both Authorities required sufficient Information to allow officers to brief Members on the progress of Project Apollo, without compromise to non-disclosure agreements.

During discussion on the Project Apollo report the Committee asked a number of questions which were responded to appropriately.

In recognising the enormous work involved in the negations and in achieving a mutual settlement between the Authorities and SSE, the committee expressed its gratitude to all officers involved in the process.
