OB10/07/12 Apologies

Apologies were received from Mrs L Arkley, Elected Mayor, Councillor J M Allan and Councillor J Pickard.

OB11/07/12 Changes to Committee Membership

It was noted that Councillor Mrs J A Wallace had replaced Mrs L Arkley, Councillor B Burdis had replaced Councillor J M Allan and Councillor T Mulvenna had replaced Councillor J Pickard for this meeting only.

OB12/07/12 Declarations of Interest

There were no declarations of interest made.

OB13/07/12 Minutes

The Minutes of the meeting held on 21 May 2012, with the addition of Councillor F Lott to the Members appointed to the Association of North East Councils, were confirmed as a correct record and signed by the Chair.

OB14/07/12 The School Governance (Constitution) (England) Regulations 2012 – Implications for the Appointment of Authority Governors.

The Committee considered a report which detailed the changes to legislation governing how governing bodies could reconstitute their membership from 1 September 2012, particularly in relation to the implications for Local Authority Governor appointments/reappointments. As a result the procedures for the appointment, re-appointment and removal of 'Authority' Governors and Communication with 'Authority' Governors would be subject to change.

The report detailed the present situation and implications of the new legislation. A number of schools would be affected if they became trust schools following consultation during the Summer term/Autumn term.

All maintained schools' governing bodies currently complied with The School Governance (Constitution) (England) Regulations 2007 in relation to their membership. From September 2012, a dual system would operate so that governing bodies that wished to retain their current membership, current school name, current terms of office for governors could do so under the 2007 regulations.

From 1 September 2012, any school that wished to make any changes to its Instrument of Government (e.g. change of name, change of membership, change of terms of office), or any school that was required to change its Instrument of Government because of a change of category (e.g. moving to trust status), must comply with The School Governance (Constitution) (England) Regulations 2012. Under the new Regulations Schools would be able to veto the nominations made by the Outside Bodies Committee but where possible, actions would be identified by the Governor Services Manager to reduce the occasions when this might happen.

Governing bodies would receive recommendations in the Autumn term from the Governor Services Manager who was proposing that governing bodies be asked to delegate the final appointment of Local Authority Governors who were nominated by the Outside Bodies Committee to the Headteacher and Chair of Governors rather than delaying the appointment of Local Authority governors by holding a full governing body meeting. However, this would have to be checked through the Department for Education, before a final recommendation was made to schools to do this.

Resolved that a system be put in place which provides a clear framework for the direct appointment or nomination for appointment of Local Authority Governors to schools in the Borough.

OB15/07/12 Exclusion Resolution
