# 1.1 Purpose:

This report sets out details of the Council's Outside Bodies which have non-executive functions and which require appointments for the 2014/15 Municipal Year.

#### 1.2 Recommendations:

The Committee considers and determines the appointment of representatives to serve on non-executive outside bodies for the 2014/15 Municipal Year.

#### 1.3 Information:

In relation to appointments to those bodies which have executive functions, the Cabinet on 12 May 2014 delegated authority to the Elected Mayor to make such appointments in accordance with the Local Authorities (Arrangements for the Discharge of Functions) (England) (Amendment) Regulations 2001.

#### PART 2 - COMPLIANCE WITH PRINCIPLES OF DECISION MAKING

#### 2.1 Finance and other resources

The proposal does not have direct financial implications. However, the completeness of this list is important in recognising the extent of indemnity cover required and ensuring the recognition of all potential liabilities the Council is committed to.

#### 2.2 Legal

The Outside Bodies Committee has the power to make appointments to outside bodies, on behalf of Council, which exercise non-executive functions (Article 6 of the Council's Constitution).

The appointment of a Member to an outside body may create liabilities for the Member (personally) and the Council (corporately). It is important that Members in the discharge of their responsibilities on outside bodies act in good faith and within the powers and responsibilities of the outside body. Members will normally be indemnified under the Council's adopted scheme of indemnification for any liabilities that flow from their appointment to an outside body. To ensure that Members benefit from the scheme of indemnity, Members should seek prompt advice from officers should they consider that they have any conflict of interest in discharging their duties on an outside body or if they are concerned that the body may be acting in a potentially unlawful way. A guidance note in relation to personal liability of members serving on outside bodies is attached to this report for Members' information.

# 2.3 Consultation/community engagement

Consultation has taken place with Senior Leadership Team to ensure the schedule of outside bodies attached as Appendix 1 is as accurate as possible.

#### 2.4 Human rights

There are no direct human rights implications arising from this report.

# 2.5 Equalities and diversity

The Council makes appointments to outside bodies which work within the requirements of equality legislation and, where applicable, the public sector equality duty.
