1.1 Purpose:

The purpose of the report is to present comments from the Overview and Scrutiny Committee in relation to Item 7 of the Agenda – Report from the Finance Sub-committee Sub-group: Budget Objection Process.

1.2 Recommendation(s):

It is recommended that Council consider the following comments put forward by the Overview and Scrutiny Committee in relation to the proposed Notice of Objection Process by the Budget Objection Sub-group:

• That the revised timelines attached to this report be adopted which provide a separate timeline for amendments related to the HRA account.

1.3 Background

The Overview and Scrutiny Committee considered the report of the Budget Objection Process Sub Group at the meeting on 5 September. Members raised concern that the timeline provided did not give sufficient clarity of the process for objections to be submitted in relation to the Housing Revenue Account (HRA) proposals. It was noted that the approval process for the HRA differed from the budget approval process, with the annual housing rent increase approved at the Council meeting on 2 February 2012 on the basis of a majority vote. Members wished to ensure that adequate time was provided in the process to allow final proposals in relation to the HRA to be fully considered and for any proposed amendments to be submitted and evaluated ahead of the meeting when the decision will be taken. In response to these queries a revised Appendix to the report has been drafted to show a separate timeline for amendments related to the HRA account.

Members also requested clarification of the voting procedure to be followed to determine the budget. The Monitoring Officer has written to members of the Committee with this information.

<u>Notes</u>

- 1. We are now part way through the detailed implementation phase of the government's Self-Financing reform proposals, which will be given statutory approval as part of the Localism Bill currently going through Parliament. The government is currently updating the financial model being used to determine the debt allocation we will take on as an authority, and we will enter into consultation on a draft settlement figure in November 2011, with a final settlement figure to be agreed in January 2012. This means that the budget proposals which will be put forward for the HRA on 18 January 2012 may not at that point contain the final proposals and may be based on the draft figures issued in November 2011. It is not envisaged however that the settlement figure in January will be significantly different from the November figures. Assuming the Localism Bill is approved by Parliament in November 2011, the published government timetable states the final self financing determinations will be published in January 2012 and therefore we would anticipate final figures to be available prior to the Council meeting on the 2 February 2012. If the final settlement is not received in line with the Communities and Local Government (CLG) timeline set out above, the dates for Amendments to the HRA may need to be revised. The Council is confirming with CLG whether they intend to introduce any new governance requirements in relation to the adoption of self financing and if this is the case these will be reported to Council and included in the timeline as required. Member briefings are being scheduled in the coming months in relation to self financing.
- 2. The decision regarding the Housing Revenue Account proposals on the 2 February 2012 will be on a simple majority basis.
