1. Purpose of Report

1.1 This report outlines the process for the setting of the Council Strategic Plan and Budget as requested at the Extraordinary meeting of the Overview and Scrutiny Committee on 9 May 2012.

2. Recommendations

2.1 It is recommended that Overview and Scrutiny Committee notes the contents of this report.

3. Details

At the Extraordinary meeting of the Overview and Scrutiny Committee on the 9 May 2012, a report was requested to be submitted to the next meeting of Overview and Scrutiny Committee which outlined the process for the setting of the Council's Budget.

By virtue of the fact this Council has adopted a joint process for developing its Council Strategic Plan and Budget along the same timescales, this report therefore covers both.

As the setting of the Council Strategic Plan and Budget is an annual process, the overarching framework for the process is agreed in advance by Cabinet, along with an engagement strategy. In addition, for the 2012/13 Notice of Objection element of the Budget Setting Process, the detailed process and timescale were agreed by Council following a review by the Finance Sub Committee.

Attached as Annex 1, is the report to Cabinet of the 12 September 2011, which set out the framework for the 2012-2015 budget setting process. This report incorporated the key milestones and dates related to the process and set out the proposed budget

engagement strategy. Table 1 below has been updated to reflect actual dates and events, where appropriate.
