1. Purpose of Report

3. Details

3.1 The purpose of the Council Plan is to set out the Authority's policy direction and strategic priorities. It will set out what the Authority will do to address the needs of the borough. It will set the delivery priorities for the Financial Planning and Budget setting process for 2014-2018.

- 3.2 The Plan will also provide the framework for partnership working through the North Tyneside Strategic Partnership and as such will replace the current Sustainable Community Strategy which was due to be refreshed this year.
- 3.3 The proposed time line for developing the Council Plan 2014-2018 "Our North Tyneside", including key steps that have already taken place, is set out below.
