# **RQ6/6/15** Application for Hackney Carriage Vehicle Proprietor's Licence – Appeal against condition of licence

The committee considered a report by the Senior Client Manager, Technical Services outlining the background to an appeal submitted by the holder of a Hackney Carriage Vehicle Proprietor's Licence against a condition attached to the licence restricting the number of passengers which could be carried in the vehicle.

Mr H was present, accompanied by his representative Mr W, and both took the opportunity of addressing the committee. Mr W, on behalf of Mr H, had submitted further information in support of the appeal.

Members examined the vehicle along with another vehicle as a comparison.

Following questions from Members, Mr H, his representative and the Officers representing the Licensing Section left the meeting to enable consideration of the matter to be undertaken in private.

**Resolved** that the appeal lodged by Mr H against the condition attached to his Hackney Carriage Vehicle Proprietor's Licence restricting the number of passengers to be carried in his Hackney Carriage Vehicle to 7 be rejected.

# RQ7/6/15 Combined Hackney Carriage/Private Hire Driver's Licence – Referral – Mr R

The committee considered a report by the Senior Client Manager, Technical Services outlining the background to a referral in respect of the holder of a Combined Hackney Carriage and Private Hire Driver's Licence.

Mr R was present and took the opportunity of addressing the committee.

Following questions from Members, Mr R and the Officers representing the Licensing Section left the meeting to enable consideration of the matter to be undertaken in private.

**Resolved** that (1) no further action be taken in respect of the conviction disclosed; and (2) Mr R's combined hackney carriage/private hire driver's licence be renewed.

# RQ9/6/15 Combined Hackney Carriage/Private Hire Driver's Licence – Referral – Mr S

The committee considered a report by the Senior Client Manager, Technical Services outlining the background to a referral in respect of the holder of a Combined Hackney Carriage and Private Hire Driver's Licence.

Mr S was present and took the opportunity of addressing the committee.

The committee, in the presence of Mr S, observed a recording of the incident which resulted in the referral to the committee.

Following questions from Members, Mr S and the Officers representing the Licensing Section left the meeting to enable consideration of the matter to be undertaken in private.

**Resolved** that Mr S be issued with a warning as to his future conduct.

#### RQ10/6/15 Combined Hackney Carriage/Private Hire Driver's Licence – Referral – Mr N

The committee considered a report by the Senior Client Manager, Technical Services outlining the background to a referral in respect of the holder of a Combined Hackney Carriage and Private Hire Driver's Licence.

Mr N was present, accompanied by a relative, and both took the opportunity of addressing the committee.
