Finalised training completions for the above mandatory courses will be tabled to the Standards Committee on 1st December 2016. Individual completion status for specific courses has been circulated to Group Leaders.

1.5 Next Steps

The Member Development Programme is reviewed annually and will be considered by the Deputy Mayor in January 2016 ready for implementation in May 2017.

Further development of the Council's online learning system (Learning Pool) is underway to provide event reminders to elected Members when training is due to expire and the learning available to meet the requirements of the member development programme.

The online learning offer will continue to increase in 2016/17 to provide more flexible methods of learning to elected Members.

Training/briefings will be made available to elected Members on the functions of Learning Pool to maximise the Council's online learning offer.
